Perseroan Mendapatkan Fasilitas Kredit dari PT Bank Rakyat Indonesia Agroniaga Tbk.

Dalam rangka memenuhi Peraturan Bapepam No. IX.E.2 tentang Transaksi material dan Perubahan Kegiatan Usaha Utama dan Peraturan Otoritas Jasa Keuangan (POJK) Nomor 31/POJK.04/2015 Tentang Keterbukaan Informasi atau Fakta Material oleh Emiten atau Perusahaan Publik, dengan ini PT Radana Bhaskara Finance Tbk (“Perseroan”) memberitahukan bahwa pada hari Rabu tanggal 16 Maret 2016, Perseroan dan PT Bank Rakyat Indonesia Agroniaga Tbk (“Bank”) telah menandatangani Perjanjian Kredit dan akta Jaminan Fidusia sehubungan Penerimaan Fasilitas Kredit dari Bank sampai dengan sebesar Rp 150 M dan dengan jangka waktu maksimal 36 bulan sejak tanggal penarikan.

Fasilitas kredit ini dijamin dengan tagihan/piutang pembiayaan sebesar 100% dari total jumlah pokok fasilitas kredit yang masih terhutang (outstanding).
